Matthew Grech (born June 24, 1989) is a Maltese worship leader, singer/songwriter, music producer and biblical sexuality activist. His bold public witness on X-Factor Malta in 2018 placed him and his country in an international spotlight. Grech stood for biblical marriage and celebrated his freedom from an unwanted homosexual lifestyle.

CIT amplified Matthew's voice at a time when his militant opponents harassed him and tried to silence him. Matthew formed a strategic bond with CIT Director Mike Davidson, and both began to work closely together to fight the current threats on gender confidence in Europe, and the rest of the world. Matthew is now CIT co-worker, actively serving CIT's European and global mission in the area of media, music and public relations.
